2025 CSA Membership Agreement Form

What we want from you:

We don't ask a lot from you. But, here is a list of what we expect:

- Pick up your share weekly at your selected location.
 - Call our farm, if you are not able to do this! The number is (828) 312-8137.
 - Any shares not picked up during the designated time will be donated to a family in need. You will not be reimbursed for your donated share.
- Bring your Farmers' Daughter CSA bags back weekly to trade out with us.

How You Get Your Share

The majority of our shares are picked up at **Our Farm** (2150 Friendship Church Road, Taylorsville, NC 28681) on Tuesdays or **Thursdays, between 4-6pm**. Customers just like coming out to the farm. They enjoy the sights and sounds of farm life; and sometimes the smells!

Our other pickup locations may be added as the season nears. Please let us know if you have any bright ideas. Our Viewmont location will be under construction and the Hickory Farmer's Market is not a good fit, during the summer and fall.

How to Communicate with Us

I will do my best to respond as soon as possible. Phone is definitely the best way; especially text messages, during the season!
- Please call me (Farmer Amy) with any questions or concerns. Our pickup location attendants are volunteers and do not know the inner workings of the farm, the shares, etc.

How We will Communicate with You

- The Farmers' Daughter will communicate with you by email and group text messages.
- Please read your text messages from our farm. We depend on being able to communicate important information such as necessary changes to your distribution schedule or to our farm events.
- We will send a bi-weekly CSA email, giving you information about the crops available that time period, recipe ideas, or other farm related news.

Application and Payment Particulars

- Fill out your application and send it with your deposit before January 30th, 2025.
- Pay your remaining balance for the Summer Subscription & Strawberry Share(s):
 - All monies are due by April 1st, 2025.
 - Payment may be made with cash or personal check.
 - Please mail the payment to **5161 Church Road, Taylorsville, NC 28681** or call (828)312-8137 to schedule dropping off your cash payment.
- You will receive an email when your payment is received.

Cancellation and Refund Policy

- You may cancel your CSA Subscription at any time, up to two weeks prior to your Subscription start date. However, you will be charged a **\$25 Administrative Fee**.
- You may cancel anytime during the growing season. However, your subscription fee refund will be pro-rated for the amount of weeks that you have participated and you will be charged the **\$50 Administrative fee**.
- The Farmers' Daughter may cancel your subscription at any time, if farm rules are broken or any of the guidelines in the 2025 Membership Agreement Form are not followed.

Crop Failure

- Our season is dictated by the weather. As a member, you share in the abundance of our harvest, as well as in the risks that come with farming. We cannot stress this part enough! Although we have learned how to avoid or manage around most problems, it is likely that EVERY year, Mother Nature will throw us a curve-ball, and we may lose a crop to drought, flooding, disease, bugs, hail, or other acts of God. This may

mean that you will not receive that particular affected crop for that season.

If this occurs, we will do our best to make up for the value of the share by substituting something else in its place or buying in produce from one of our farm partners. We will communicate regularly to keep you informed of our crops and any issues that may be happening. We ask that you be patient with us as we do our best to come up with a “Plan B”.
